1. **PROMOTION DESCRIPTION:** The **Kellogg's Raisin Bran x IFL Custom Raisin Bran Watch Giveaway** (the "Sweepstakes") is a social media Sweepstakes that begins on 3/3/2026 at 12:00:00 AM Eastern Time ("ET") and ends on 3/13/2026 at 11:59:59 PM (ET) (the "Promotion Period").

Throughout the Promotion Period, eligible entrants will have the opportunity to post a comment in response to the Sweepstakes post by the **Raisin Bran Kellogg's®** Instagram account (**@raisinbran\_us**) made on **2/9/2026** and include the **(tag a friend, follow @raisinbran us and comment "It's Fiber Time")** (as defined below); and follow the **@raisinbran\_us** Instagram account on Instagram (collectively, the "Submission"), as more fully set forth below. There will be 1 Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period.

By participating in the Sweepstakes and completing a Submission (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the WK Kellogg Co ("Sponsor"), which shall be final and binding in all respects.
