OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION:** The **RACE DAY GIVEAWAY**
2. (the “**Sweepstakes**”) is a social media Sweepstakes that begins on **4/30/25** at 12:00:00 AM Eastern Time (“**ET**”) and ends on **5/04/25** at 11:59:59 PM (ET) (the “**Promotion Period**”).
